Aplicación

Se alterna hileras o plantas, se aplica al 50% de el cultivo.

Frecuencia

Cada 7 días, dependiendo del monitoreo de 4 a 8 aplicaciones.

CONTROL ETOLÓGICO

Se basa en el uso y aprovechamiento del comportamiento y hábitos del insecto para su control.

CONTROL
MASIVO

Consiste en cubrir parte de la superficie del cultivo con estaciones cebadas con atrayentes.

CERATRAP
200 a 250
ml/estación
30 a 50
estaciones/ha

Elaboración de estaciones de cebo



Realizar 4 agujeros:

1. Lugar: Tercio superior de la botella.
2. Tamaño: 2 cm de diámetro
